As former Director of International Education for over 10 years, she led ASU first study abroad programs to China, Peru, and Ghana and engaged scores of faculty members in leading programs abroad and internationalizing home courses for all students' global learning. She also internationalized several composition courses herself and mentors faculty in the process. As a

result, over 130 courses have been internationalized, all culminating in ASU's 2023 NAFSA Senator Simons Spotlight Award for Curriculum Internationalization Initiatives.

Dr. Osakwe is editor and co-editor of books and articles. Currently, she serves on the editorial board of *International Research and Review (IRR)*, Journal of Phi Beta Delta, Honor Society for International Scholars. She initiated the publication of two Special Issues on Internationalizing the Curriculum with 14 articles by ASU Faculty members (IRR Journal Vol. 11 No. 2, Spring/Summer 2022 and Vol. 6. No. 2 Spring 2017). She is the Founder and Chief Editor of *ASU Global Issues*. Dr. Osakwe is named a University System of Georgia (USG) Leadership Fellow-2021, and she is the recipient of the 2022 NAFSA Region VII Award for Diversity, Equity, and Inclusion in International Education. She is a recipient of the 2025 Fulbright International Education Administrators (IEA) Award for France and Senegal and serves as ASU Fulbright Advisor.
