Competence through Volunteering Paper

Instructions:

Students will complete a 5-8 page paper on their volunteer experience while in SOWK 3442: Social Work Practice II: Groups. The paper will address the following Sections:

Section I: the name and address of the agency

Section II: the services the agency provides

Section III: the populations served by the agency

Section IV: the responsibilities the volunteer student was given at the agency

Section V: a discussion on how either the student demonstrated the following course competencies *or* observed a social worker/human service worker demonstrated the following social work competencies addressed in SOWK 2412: Introduction to Social Work.

12. I demonstrated the ability to use empathy, reflection, and interpersonal skills to effectively engage diverse clients and constituencies.
13. I demonstrated the ability to collect and organize data, and apply critical thinking to interpret information from clients and constituencies.
14. I demonstrated the ability to develop mutually agreed-on intervention goals and objectives based on the critical assessment of strengths, needs, and challenges within clients and constituencies.
15. I demonstrated the ability to select appropriate intervention strategies based on the assessment, research knowledge, and values and preferences of clients and constituencies.
16. I demonstrated the ability to critically choose and implement interventions to achieve practice goals and enhance capacities of clients and constituencies.
17. I demonstrated the ability to use inter-professional collaboration, as appropriate, to achieve beneficial practice outcomes.
18. I demonstrated the ability to negotiate, mediate, and advocate with, and on behalf of, diverse clients and constituencies.
19. I demonstrated the ability to facilitate effective transitions and endings that advance mutually agreed-on goals.
20. I demonstrated the ability to select and use appropriate methods for evaluation of outcomes.
21. I demonstrated the ability to critically analyze, monitor, and evaluate intervention and program processes and outcomes
22. I demonstrated the ability to apply evaluation findings to improve practice.

Organization	The structure of the paper is clear and follows the required outline in a detailed manner.	The structure of the paper is clear and follows the required outline. Course Competencies Program Outcomes	The paper discusses all course competencies and how they were addressed during the student's volunteer experience in detail.	The paper generally discusses all of the course competencies assigned to this course and how they were addressed during the student's volunteer experience.	The paper minimally addressed each of the course competencies assigned to this course and how they were addressed during the student's volunteer experience.	The paper does not discuss the course competencies nor does it discuss examples of how the competency was demonstrated during the student's volunteer experience.
Mechanics Spelling, Punctuation, Capitalization	The paper is well-organized and free of grammatical and mechanical errors. The paper is 7-8 pages in length.
