Student Organization Events and Activities

- The Office of Student Engagement does not support nor encourage student organizations meeting in person in the residence halls or off campus to conduct organization business.

- The Office of Student Engagement is not sanctioning any university related travel for RSO's at this time. We will continue to monitor conditions and reevaluate this position at a later date.
- If you're planning to participate in community outreach or service activities, please defer to the guidance of the agency or community organization you are working with.
 - COVID-19 (or any illness) can severely impact certain populations such as the elderly, immunosuppressed, and those with pre-existing conditions.
 - As you continue to make plans, please consider both individual and community impacts.
 - Also, on the Virtual Engagement page there will be a list individual virtual service projects to keep you engaged.
