6. Provide Narrative:

Undergraduate research is an investigative, original intellectual activity by an undergraduate student which leads to a measurable contribution to the discipline. The Council for Undergraduate Research (CUR) defines Undergraduate Research as “An inquiry or investigation conducted by an undergraduate student that makes an original intellectual or creative contribution to the discipline, CUR, 2011).” This definition is sync with Albany State University’s strategic initiative (Goal 2: Strategy 2.1), “To create a distinctive culture of discovery with enhanced opportunities for all university stakeholders.”

The Center for Undergraduate Research (CUR) at Albany State University works with students, faculty, and our leaders to create research awareness and to emphasize its importance. The center trains students, faculty, and staff on research methods, the center promotes undergraduate conferences and conference research paper presentations, and it supports student research publications in referred journals and proceedings. It is well known that student engagement in learning, including out-of-class learning experiences such as undergraduate research, has substantial positive impact on student success and achievement, retention, progression, persistence, and graduation. Student participants have more one-on-one contact time with their mentors, become more confident, increase quality time-on-task, and are able to progress to graduate schools, professional schools, or seek and secure high paying jobs.

CUR student participants have continued to outperform other students at Albany State University. They have maintained a higher mean Grade Point Average (GPA) than the general student population. While the mean GPA of ASU students were 2.66, 2.72, and 2.70 for 2013, 2014, and 2015 respectively, the mean GPA of CUR participants were 3.14, 3.07, and 3.14 for 2013, 2014, 2015 respectively. This is statistically significant. CUR will continue to provide for participants and their mentors support and opportunities to enhance student research and creative activity skills and knowledge. CUR will continue to foster their zeal to remain persistent, to complete assigned tasks, to increase their success in their courses and programs, and to progress and graduate on time, and remain confident in their pursuit for promising careers and graduate education.
