We have reviewed your request to approve the final list of degree programs at the new Albany State University. The attached list will serve as the official record of your approved consolidated degree program inventory, effective July 1, 2017. I would like to take this opportunity to thank you and your faculty and staff (at both campuses) who worked diligently to determine what the program offerings at the new institution should be. I also appreciate how your team worked closely with my staff to finalize the inventory.

- Master of Education with a Major in Teaching Field – Science (CIP Code 13131637) to Master of Education with a Major in Secondary Education (CIP Code 131205)
- Bachelor of Science with a Major in Special Education (CIP Code 13100125) to a Bachelor of Science with a Major in Secondary Education (CIP Code 131205)

The list also includes seven programs that will be deactivated effective the date of this letter. Deactivation provides the institution up to two years to determine the future viability of these programs. It is expected that these seven programs will either be reactivated or requested for termination no later than January 5, 2019.
