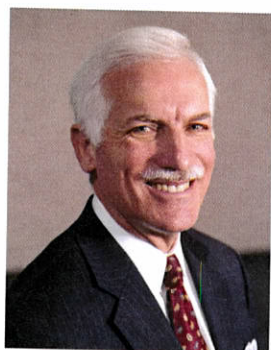

Mr. Alford is President and Chief Executive Officer of Allied Energy Services and is currently responsible for over \$5 billion of energy projects in Central and North America. He has served as consultant to the U.S. Congressional Office of Technology Assessment on energy policy issues. Mr. Alford earned his Bachelor of Electrical Engineering from Georgia Tech. He is a member of the Board of Trustees and Chairman of the Georgia Tech Alumni Association, a member of the Georgia Tech Foundation, an inductee of the Academy of Distinguished Engineers and was awarded the Dean Griffin Award for Community Service. In 2003, Governor Sonny Perdue appointed Mr. Alford to the State Board of Education for the State of Georgia where he served until 2006. In January 2007, Governor Sonny Perdue appointed him to the Technical College System of Georgia board of directors and served as its Chairman from 2009 to 2011. Governor Nathan Deal appointed him to the Board of Regents of the University System of Georgia in January 2012. Mr. Alford is a member of the Georgia Chamber of Commerce Board of Directors.

From 1983 until 1993, He was a five-term member of the Georgia House of Representatives. Of all his activities and accomplishments, Mr. Alford's most enjoyable and important role is that of husband and father. He and his wife Debbie have five children and two grandchildren.

**W. Paul Bowers**

Paul Bowers was named chairman, president and chief executive officer of Georgia Power, effective Dec. 31, 2010. The company is the largest subsidiary of Southern Company, one of the nation's largest producers of electricity. Bowers joined the Southern Company system at Gulf Power in 1979 and has held executive leadership positions at multiple subsidiaries. Prior to his current position, he was chief financial officer of Southern Company, where he was rated by Institutional Investors magazine as one of the industry's Top Three CFOs in America. In 1998, Bowers was elected president and CEO of South Western Electricity plc, Southern Company's former U.K. subsidiary. From 2001 to 2008, he served as president (currently titled chief operations officer) of Southern Company

Generation, where he was responsible for the company's overall operational activities. He also served as CEO of Southern Power. Bowers serves on the boards of Nuclear Electric Insurance Ltd., AFLAC, the Board of Regents of the University System of Georgia, the Georgia Research Alliance, the Georgia Historical Society, Children's Healthcare of Atlanta Foundation and the Atlanta Committee for Progress. He is the 2015 chair-elect of the Georgia Chamber of Commerce, as well as a member of the Federal Reserve Bank of Atlanta's Energy Policy Council and a trustee for The Woodruff Arts Center. He is the past chair of the Metro Atlanta Chamber of Commerce and the Georgia Partnership for Excellence in Education. A Pensacola, Fla., native, Bowers holds a Bachelor of Science degree from the University of West Florida and a master's degree in management from Troy University. He is also a Harvard Business School Advanced Management graduate

Griffin Corporation partnered in joint venture with Dupont in 1998 eventually selling its interest in the joint venture to Dupont in 2003. Griffin serves as a co-chair on the capital campaign for the Boys and Girls Club of Valdosta and has served on the Georgia Ports Authority, Emeritus Trustee of the University of Georgia, and is past chairman of the South Georgia Fellowship of Christian Athletics. Born and raised in Valdosta, Griffin attended Abraham Baldwin Agricultural College in Tifton, Georgia, and received a B.S. degree from the University of Georgia with a major in Agriculture and a minor in Business in 1966. 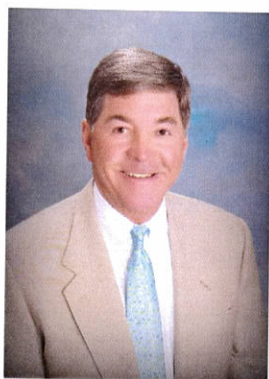

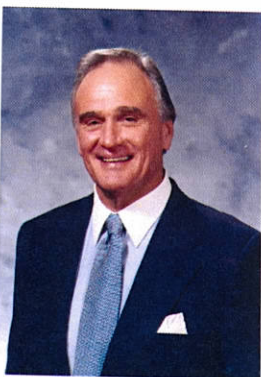

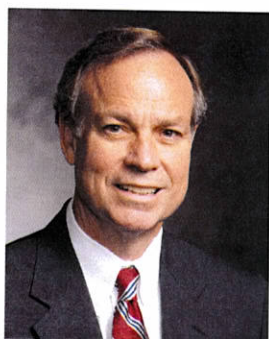
